Our Mission

The Coroner investigates the facts and circumstances concerning a wide variety of deaths which appear to have happened within the County, regardless of where the cause thereof may have occurred. The purpose of the investigation shall be to determine the cause of any such death and to determine whether or not there is sufficient reason for the Coroner to believe that any such death may have resulted from criminal acts or criminal neglect of persons other than the deceased.

Jurisdiction

The Coroner's Office is mandated by the Commonwealth of Pennsylvania to investigate and determine the cause and manner of death. These include cases of homicide, suicide, accidental, and all natural deaths that are sudden, unexpected or medically unattended. Accordingly, the cause and manner of death are determined by means of investigation, toxicology and post mortem examination (autopsy) and the death certificate is then issued based on those findings.

The autopsy is vital in the determination of a definitive cause and manner of death. Autopsy objections from the next of kin are considered only after an autopsy waiver is signed at the Coroner's Office. Please be advised that the autopsy waiver in itself does not preclude the autopsy. Without this critical and often necessary procedure, it is more difficult for the Coroner's Office to accurately determine a cause and manner of death.

In 1990, legislation was added to the county code requiring Coroners to investigate "*deaths of persons whose bodies are to be cremated, donated, buried at sea or otherwise disposed of as to be thereafter unavailable for examination*". It is the Funeral Director's responsibility to contact the Coroner for appropriate authorization when final disposition is cremation, donation, burial at sea, etc.

Release of Remains

and

Personal Possessions

In an effort to allow the legal next of kin to proceed with funeral arrangements and final disposition of a loved one, the Coroner's Office attempts to release the body in a timely fashion. At times an autopsy and/or organ donation can delay the release of the body. The Coroner's Office will communicate with the Funeral Home regarding the release of the remains so proper planning can proceed.

The Coroner's Office does not select, recommend or make funeral arrangements.

Personal possessions of the deceased in the custody of the Coroner may be claimed by the legal next of kin, providing that they are not being held as evidence. To avoid any inconvenience, an appointment is recommended. A photo identification is required prior to the release of personal effects. Unless there is a need to hold the clothing as evidence, it is released to the Funeral Director recovering the deceased. Clothing that presents a health hazard may be disposed of for the safety of all persons involved.

Appointments for the release of personal effects can be made from 8 am to 4 pm Monday through Friday.

Organ Donation

Although facing the death of a loved one is overwhelming, a decision regarding organ donation may present the opportunity to save lives. Once it is determined that your loved one has no medical conditions that would medically preclude the organ donation, a representative from the Center for Organ Recovery and Education will advise and discuss your options. The organ donation procedure will not be performed without the authorization of both the next of kin and the Coroner's Office.

Copies of Reports

Final autopsy, toxicology and investigation reports are available for release ONLY to the legal next of kin. The Coroner's Office requires written permission from the next of kin prior to the release of all reports. There is no charge for the initial copy of the reports to the legal next of kin. The fees for all additional copies for legal, insurance, and other reasons are as follows:

Autopsy	\$100.00
Toxicology	\$50.00
Investigation	\$50.00

* Payment for all reports must be made in advance.

Death Certificates

Once the determination is made regarding the manner and cause of death, a death certificate is generated to the responsible Funeral Home. The original certificate is filed with the Pennsylvania Division of Vital Records by the Funeral Director. Certified copies of this certificate can be obtained from the Funeral Director or the Division of Vital Records at a minimal cost.
