<u>Incident Details:</u> <ul style="list-style-type: none">▪ Westmoreland County Coroner, Kenneth A. Bacha, has released the following information on a motor vehicle collision with two fatalities that occurred in Donegal Township.▪ Shari L. Kohan was the operator of a 2007, Ford Focus, traveling south on State Route 711.▪ Gloria J. Randall was a passenger of a 2013, Subaru Outback, traveling north on State Route 711.▪ For an unknown reason, the Ford Focus crossed the centerline into the opposite lane of travel and struck the Subaru Outback in a head-on type collision.▪ The operator of the Subaru Outback was flown by medical helicopter to a Pittsburgh hospital.▪ Deputy Coroner Jonathon Jenkins pronounced both decedents dead at the scene.▪ Speed is believed to have been a factor in the incident.▪ A seat-belt was not utilized by Shari L. Kohan.▪ A seat-belt was utilized by Gloria J. Randall.▪ Cell phone use being a factor in the incident is unknown at this time.▪ The cause and manner of death for both decedents is reflected above.▪ Toxicology results will not be available for several weeks.▪ Brooks Funeral Home of Melcroft will be in charge of arrangements for Gloria J. Randall.▪ Duca Funeral Home of Johnstown will be in charge of arrangement for Shari L. Kohan.▪ Pennsylvania State Police Greensburg Barracks also investigated the incident.
